# **Abu Dhabi SWF gets** full I-T waiver for infra investments

**FE BUREAU** New Delhi, November 3

THE GOVERNMENT HAS notified Abu Dhabi's MIC Redwood 1 RSC as the first sovereign wealth fund (SWF) to be eligible for full income tax exemptions on gains from longterm investments in specified priority infrastructure sectors in the country.

The Finance Act, 2020, provides for income tax exemption on income from interest, dividend and long-term capital gains for specified infrastructure investments. "This 100% income tax exemption

facility was well received by SWFs and pension funds across the globe, and a large number of SWFs and pension funds have shown interest in investing in India's infrastructure sector," a finance ministry official said.

The government's NIIF Master Fund has raised funds from a clutch of investors, including the Abu Dhabi Investment Authority (ADIA), Temasek of Singapore, the Canada Pension Plan Investment Board (CPPIB) and Australian Super. ADIA alone has committed \$1 billion, while CP-PIB has pledged \$600 million and Temasek \$400 million.

# Centre's draft electricity rules overrides state, regulators' jurisdiction, say CERC, WB govt

INDRONIL ROYCHOWDHURY Kolkata, November 3

THE WEST BENGAL government has objected to the Union power ministry's proposed rules for a late payment surcharge on electricity, terming it the Centre's attempt to intrude into the jurisdiction of the state and the regulatory commission.

The Central Electricity Regulatory Commission (CERC) has virtually termed the rules, null, saying that "rules must be made to enable legislation" of the Electricity Act (EA) 2003. It said the rules seek to make changes to the provisions of the Act and encroach on the powers of the regulator by fixing surcharges and inter-state transmission charges."The objective of the EA

2003 is to distance the regulatory [functions] from the government vesting it on the regulatory commissions. Powers and functions of the central and state regulators have been specified in the EA 2003," a CERC letter to the power ministry said.

West Bengal's power department, meanwhile, has said that the rules encroach on the power of the state regulator provided in Sections 43(1), 45, 50 and 86(1)


